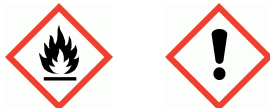

SECTION 4: First aid measures

4.1. Description of first aid measures

General information	If in doubt, get medical attention promptly. Show this Safety Data Sheet to the medical personnel.

SECTION 5: Firefighting measures

5.1. Extinguishing media

Suitable extinguishing media The product is flammable. Extinguish with alcohol-resistant foam, carbon dioxide, dry powder or water fog.

Unsuitable extinguishing media Do not use water jet as an extinguisher, as this will spread the fire.

5.2. Special hazards arising from the substance or mixture

Specific hazards Containers can burst violently or explode when heated, due to excessive pressure build-up. Bursting aerosol containers may be propelled from a fire at high speed. If aerosol cans are ruptured, care should be taken due to the rapid escape of the pressurised contents and propellant. Vapours may form explosive mixtures with air.

Hazardous combustion products Thermal decomposition or combustion products may include the following substances: Toxic gases or vapours. Carbon monoxide (CO). Carbon dioxide (CO₂).

5.3. Advice for firefighters

Protective actions during firefighting Avoid breathing fire gases or vapours. Evacuate area. Cool containers exposed to heat with water spray and remove them from the fire area if it can be done without risk. Cool containers exposed to flames with water until well after the fire is out. 6.2. Environmental precautions

Environmental precautions Avoid discharge into drains or watercourses or onto the ground. Not considered to be a significant hazard due to the small quantities used.

6.3. Methods and material for containment and cleaning up

Methods for cleaning up Clear up spills immediately and dispose of waste safely. Eliminate all ignition sources if safe to do so. No smoking, sparks, flames or other sources of ignition near spillage. Under normal conditions of handling and storage, spillages from aerosol containers are unlikely. If aerosol cans are ruptured, care should be taken due to the rapid escape of the pressurised contents and propellant. Provide adequate ventilation. Small Spillages: Wipe up with an absorbent cloth and dispose of waste safely. Large Spillages: If the product is soluble in water, dilute the spillage with water and mop it up. 7.1. Precautions for safe handling

Appropriate engineering controls

Provide adequate ventilation. Observe any occupational exposure limits for the product or ingredients.

Eye/face protection

Unless the assessment indicates a higher degree of protection is required, the following protection should be worn: Tight-fitting safety glasses. Personal protective equipment for eye and face protection should comply with European Standard EN166.

Hand protection

To protect hands from chemicals, gloves should comply with European Standard EN374.
